OBEDIENCE RULES AND REGULATIONS

These rules and regulations are to be read in conjunction with the Kennel Club Obedience Show Regulations G under which this show is licensed. It is the responsibility of everyone entering this show to make themselves familiar with the Kennel Club G Regulations, available from the Kennel Club.

- Dogs entered at Kennel Club licensed Obedience Shows must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.
- All dogs registered and resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 3. Only dogs of six calendar months of age and over are eligible for competition at Kennel Club licensed Obedience Shows.
- 4. A dog must not compete in the same class more than once, including special classes.
- 5. Organisers of Open Obedience shows may set a capping level on the entries to be accepted in any standard or special class, and may decline entries received after the capping level has been reached. State if specific classes are to be capped and the capping limit. The capping level must be set at a minimum of 35 entries received. There is no maximum level at which a cap may be set.
- Not for competition entries will be accepted for dogs aged four calendar months and over. Dogs must be Kennel Club registered with their full details recorded on the entry form.
- The running orders will be sent by e-mail to relevant competitors unless a competitor has clearly stated they wish to receive their running orders by post.
- 8. The Committee reserves to itself the right to refuse entries.
- 9. In the event that the show is cancelled due to unforeseen circumstances, the society will refund fees, less reasonably incurred expenses. If the show processor has the provisions to do so, competitors will be refunded in the manner in which they had entered the show, but in any event the society will refund fees within 3 months of the show date to all those who had entered and requested a refund within 1 month of the show date.
- 10. In classes without a full running order dogs will be received until one hour after the commencement of judging 10am after which no dogs may be received except under unforeseen and exceptional circumstances and by special permission of the Show Management.
- 11. For the duration of the show all dogs, including those in the exercise area, must be on a lead except when competing or practising prior to competition.
- 12. The mating of bitches within the precincts of the competition is forbidden.
- 13. The dog should be led into the ring for judging with a smooth collar or, half-check collar, with lead attached (unless otherwise directed) and should be at the handler's side.
- 14. Animals allowed in Event
 - a. No animal other than one officially entered shall be brought into the precincts of the event during its continuance, except any dogs registered to assist the disabled, or dogs required for educational or instructional purposes or by permission of the Board.
 b. However, at the discretion of the show society, a dog brought to the show by a spectator may be admitted into the precincts of the dog
 - b. However, at the discretion of the show society, a dog brought to the show by a spectator may be admitted into the precincts of the dog show, with the proviso that those in charge of the dog sign a declaration confirming the dog is free from disease and that the dog will be kept under proper control at all times.
- 15. Following discussion between the Chief Steward and the show management and/or a veterinary surgeon, a dog shall be prevented from competing and/or removed from the Show if it is:-
 - A bitch which is in season.
 - b. Suffering from any infectious or contagious disease.
 - c. Interfering with the safety or chance of winning of an opponent.
 - d. Of such temperament or is so much out of control as to be a danger to the safety of any person or other animal.
 - e. Likely to cause suffering to the dog if it continues competing.
 - c. The circumstances of such a removal shall be recorded in the show Incident Book and submitted to the Kennel Club.
- 16. Dogs will be disqualified if proved to have been handled in the class by the scheduled judge's spouse or immediate family, or resident at the same address as the scheduled judge.
- 17. No person shall carry out punitive correction or harsh handling of a dog at any time within the boundaries of the Show.
- 18. No competitor shall impugn the decision of the Judge or Judges.
- 19. Should a judge be unable to fulfil the appointment to judge the Committee reserves the right to appoint another judge.
- 20. Should circumstances so dictate the Society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to the Kennel Club.
- 21. DOGS IN VEHICLES ON HOT DAYS
- Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take
 care of your dog-If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage
 caused.
 - 22. Welfare of Dogs
 - a. A competitor whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any Obedience show licensed by the Kennel Club. This shall apply at the venue and within the precincts of the show.
 - 23. Food and/or toys shall not be carried or given to a dog under test except in Introductory Class where silent toy and food rewards may be used between and after exercises and in a Special Class if specified in the class definition. Competitors must not distract other dogs when rewarding their dog with food, toy or play. (Refer to Obedience Code of Conduct)
 - 24. Any dog which is not presented for stay or scent exercises when called for testing will be considered to have withdrawn from the class.
 - 25. After commencement of judging the responsibility for dogs being brought to the ring to compete is entirely the competitors.
 - 26. The maximum number of entries allowed in any class is 60.
- 3. 27 Once a dog has commenced competing in a Class, no substitution of handler is permitted in that Class.
 - 27. The Show will open at 8.30 am
 - a. Judging will commence at 9 am Sharp.
 - b. The Show will close half an hour after all judging has been completed.
 - c. Entry fees per Day: £5 per dog per class

- In the following Definitions of Classes First Prize wins in Limited Show Obedience Classes and Open Shows confined to one breed do not count for entry in Open and Championship Show Obedience Classes but do count for eligibility at Limited Obedience Shows or Open Shows confined to one breed.
- A dog must be entered in the lowest scheduled class for which it is eligible and may also be entered in another class if desired, plus one additional class at the society's discretion. Exemptions from this regulation are:- A dog entered in a Good Citizen Dog Scheme Special Pre-Beginner Obedience Stakes Class or

A dog entered into a Young Kennel Club (YKC) Obedience Class which may also be entered in a maximum of two other scheduled classes (including YKC classes) for which it is eligible or

A dog only entered in a special class (or classes) provided such a class (or classes) are defined in the schedule. Such entries must be made in line with the show's closing date for entries.

3. In estimating the number of awards won, all wins up to and including the seventh day before the closing date for entries shall be counted when entering for any class

- 11. Not for competition entries will be accepted for dogs aged four calendar months and over. Details of each dog must be recorded on the entry form and must be Kennel Club registered.
- 12. In the event that the competition is cancelled due to unforeseen circumstances, the society will refund fees, less reasonably incurred expenses. If the show processor has the provisions to do so, competitors will be refunded in the manner in which they had entered the competition, but in any event the society will refund fees within 3 months of the competition date to all those who had entered and requested a refund within 1 month of the competition date.
- 13. Should a judge be unable to fulfil their appointment the organiser reserves the right to appoint an alternative judge.
- 14. It is the competitor's responsibility to be available for their class and running order.
- 15. Should circumstances so dictate the organiser, in consultation with the judges, may alter arrangements as necessary. Such changes will be reported to the
- 16. Only dogs of six calendar months of age and over on the first day of the competition are eligible to take part in Level 1, 2 & 3 classes. Only dogs of 12 calendar months of age and over on the first day of the competition are eligible to take part in Level 4 or higher classes or special classes which incorporate jumps or similar exercises
- 17 Organisers of Open Rally competitions and Limited Rally competitions may set a capping level on the entries to be accepted in any standard or special class and may decline entries received after the capping level has been reached. - 23. For the duration of the competition and including those in the exercise area, all dogs must be on a lead except when competing or practising prior to competition.
- 24. Food or toys shall not be carried in the ring or given to a dog whilst under test.
- 25. A dog cannot be entered in the same class more than once.
- 26. Once a dog has entered the ring to compete, no further practice may be carried out.
- 27. A dog must, at the time of entry for the competition, be registered as required by Kennel Club Rules and Regulations in the owner's name (or registration or transfer applied for). In the case of joint registered owners the full name of every registered owner must be given. Where an owner makes an entry on behalf of another joint registered owner(s) or where an agent enters on behalf of a single or joint registered owner(s) such person must have the authority and consent from the single or joint registered owner(s) to sign the entry form on their behalf thereby binding them all to Kennel Club Rules and Regulations. In the event of any dispute, evidence of such authority and consent will be required. A dog acquired subsequent to entry having been made at a Competition may compete as the new owner's property provided that an application for the transfer has been forwarded to the Kennel Club before the Competition, and the new owner has undertaken to abide by the Regulations and conditions of the original entry form (and in accordance with the conditions set out above).

Animals in Event.

No animal other than one officially entered shall be brought into the precincts of a competition during its continuance, except any dogs registered to assist the disabled, or dogs required for educational or instructional purposes or by permission of the Board. However, at the discretion of the host organisation, a dog brought to the show by a spectator may be admitted into the precincts of the competition, with the proviso that those in charge of the dog sign a declaration confirming the dog is free from disease and that the dog will be kept under proper control at all times

ELIGIBILITY AND SCHEDULE OF CLASSES

Classes at Rally Competitions

A competition host may stage one or more special classes not conforming to the standard class tests set out in Annex C of the Regulations. Such classes must contain the word 'Special' in the title of the class, and shall not count towards progression, titles or awards in standard competition classes.

Levels:

Rally handler/dog teams compete in their lowest eligible class from Level 1 to Level 6. They may also compete at the subsequent level.

Progression to the next level does not require either wins or places. Progression is dependent upon gaining three Excellent scores, under three different judges, or six qualifying scores under four different judges.

Levels 1 - 4 have a qualifying score of 175 out of 200.

Levels 5 & 6 have a qualifying score of 180 out of 200.

Scores equivalent to these qualifying scores (or greater) earned at Limited Rally Competitions do not count towards Progression, Rally Level Titles or Excellent titles.

In all levels a qualifying score of 190 or above equates to an excellent score.

Eligibility:

When entered for a competition, a dog must be entered in a standard class at the level for which it is eligible. The dog may also, if desired, be entered in up to two additional classes, one further standard class at the next level up, if scheduled, one additional special class, if scheduled, or two additional special classes. A dog may be entered in special classes only, up to a maximum of 3 classes. Special classes do not count towards progression. Once a dog has gained any level or excellent title, it is no longer eligible for any lower level.

Rally Level Titles or Excellent Titles.

In the following definitions, 'achieved a Level 1 Title', 'achieved a Level 2 Title' and so on means that the dog meets the requirements at the relevant Level.

- Level 1 Open to dogs which have not achieved a Level 1 or Level 1 Excellent Title.
- Level 2 Open to all dogs which have achieved a Level 1 or Level 1 Excellent Title, except those that have achieved a Level 2 or level 2 Excellent Title. Dogs eligible for and entered at Level 1 may also enter at this Level.
- Level 3 Open to all dogs which have achieved a Level 2 or Level 2 Excellent Title, except those that have achieved a Level 3 or Level 3 Excellent Title. Dogs eligible for and entered at Level 2 may also enter at this level.
- Level 4 Open to all dogs which have achieved a Level 3 or Level 3 Excellent Title, except those that have achieved a Level 4 or Level 4 Excellent Title. Dogs eligible for and entered at Level 3 may also enter at this level
- Level 5 Open to all dogs which have achieved a Level 4 or Level 4 Excellent Title, except those that have achieved a Level 5 or Level 5 Excellent Title. Dogs eligible for and entered at Level 4 may also enter at this level.
- Level 6 Open to all dogs which have achieved a Level 5 or Level 5 Excellent Title. Dogs eligible for and entered at Level 5 may also enter at this level.
